Deck Coatings :

Whilst applying Triflex Cryl Primer 287 to a car park top deck, primer was able to run through cracks within the soffit that had not been obvious prior to application – the primer dripped onto several cars parked on the level below. We learnt that when working on car parks we should advise that all decks below be cleared to avoid potential seepage and damage.
